An Environmental Impact Statement (EIS) is being prepared to document the potential environmental impacts of various alternatives and determine how these alternatives meet the long-term management objectives identified for the Capitol Lake/Lower Deschutes Watershed. The primary alternatives to be evaluated, at a minimum, include a Managed Lake, a Restored Estuary, a Hybrid, and a No Action Alternative (required in an EIS).

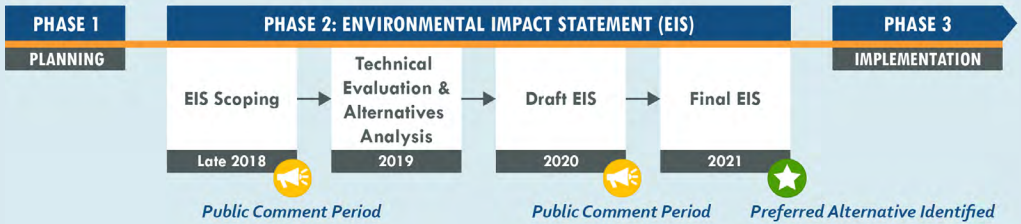

SCOPING COMMENT PERIOD: SEPTEMBER 26 - NOVEMBER 13, 2018

The first step of an EIS is called scoping. During this phase, agencies, tribes, local communities, organizations and the public will have an opportunity to comment on what should be analyzed and considered in the EIS. Comments must be postmarked or submitted electronically no later than Nov. 13, 2018.
